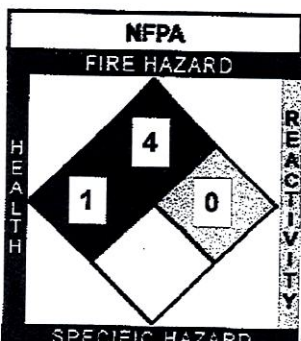

4 FIRST AID MEASURES

- Inhalation:** Move to fresh air and keep at rest. Call a physician if symptoms develop and persist.

7 HANDLING AND STORAGE
