4. Pallets must be unbroken, free of debris or pest and /or other contamination, and shall be in good to excellent condition
5. The number of product lots on a pallet must be limited to a maximum of two.

**STORAGE CONDITIONS:**

Store in ambient conditions.

**SHELF LIFE:**

2 years (730 Days)

**Assemble the pallet:**

1. The cartons are palletized
2. Place slip sheet between each pallet and the first layer of the cartons.
3. Attach a placard/pallet tag to inside of stretch wrap or to corrugate before pallet is wrapped, as placards/labels affixed to outer portion of shrink wrap are often lost or torn off.
4. The pallets are then stretch wrapped.
