


## **BABY CHANGING STATIONS**

#### **NEW NYC REQUIREMENT FOR DIAPER CHANGING ACCOMMODATIONS**

In the effort to provide both men and women with access to safe, sanitary, and convenient spaces to change their babies diaper, requirements for public locations are rapidly expanding across the nation. Regulations state that venues must be equipped with at least one changing station, deck, table or similar amenity on each floor with a public restroom.

Section 1. Section BC 1109 of the New York City building code is amended by adding a new section 1109.2.4 to read as follows: Diaper changing accommodations. In assembly and mercantile occupancies, on each floor level containing a public toilet room, both male and female occupants shall have access to at least one safe, sanitary and convenient diaper changing station, deck, table or similar amenity.

Effective July 8th, 2018, legislation requires these modifications for any new construction and large-scale renovations.

The BABIES Act, effective **October 7th, 2017**, requires restrooms in public buildings to be equipped with baby changing facilities that the General Services Administration (GSA) determines are physically safe, sanitary, and appropriate.
